- 5) All shotgun starts must have a minimum of **80** players.
- 6) **Tournament chairperson will provide to The Links Golf Club a complete list of pairings/starting times at least five (5) days prior to the start of the tournament.**
- 7) The Links Golf Club reserves the right to discontinue play due to violation of this contract at any time, with no refunds.
- 8) Due to the Idaho State Alcoholic Beverage Control laws, **all Food and Beverages** must be purchased through The Links Golf Club. The Links Golf Club agrees to provide adequate refreshments at fair and reasonable prices.
- 9) This is the entire agreement of parties; any changes must be in writing and signed by both parties.
